10. FROM MUFTI'S DESK

QUESTION: What is the Shariah law for intentionally breaking ones fast?

ANSWER: In principle, if a Baligh (mature) person intentionally breaks a fast in Ramadhan after starting it, then Qadha and Kaffarah becomes binding on him.Therefore, if you had made intention to fast and then broke the fast after starting it, Qadha and Kaffarah will be binding on you. However, there is leeway to keep one Kaffarah (60 consecutive fasts) for all the past Ramadhan fasts that one broke. There is no Fidya for delaying the Qadha fasts in the Hanafi Madhab. Fidya is only for a person who is permanently unable to fast.

QUESTION: Due to my mother's illness, she cannot fast. Is there any way for her to repay for her fast?

ANSWER: If your mother is experiencing such an illness that she is unable to fast, due to her deteriorating health, then she will be excused from fasting. If she is expected to recover from her illness, then she has to make up (Qadhaa of) these missed fasts. However, if the sickness is permanent and there is no hope of recovery then she must offer fidya (monetary compensation) for every missed fast. The value of this Fidya is the same as Sadaqatul fitr.

QUESTION: From the annual calculations of zakah, do we need to deduct the following amount as deductible liabilities from my assets in order to find the net value on which zakah (2.5%) will be applicable? The liabilities as follows: Car Lease Payment (next 12 months), Apartment Rent Charges (12 months), Children School Fee (12 months), Tax Payable to Govt. (Annual), Utilities Bills (12 Months), Other Liabilities (Purchasing food commodities for oneself and his family - next 12 months).

ANSWER: After completing one year on the nisab of zakah it is mandatory to pay 2.5% zakah after calculating all the zakatable items. At the time of completing the year the amount shall not be deducted for future needs. Hence amount equal to the car lease, rent of flat, school fees of

children, bills related to other facilities and the eatables for oneself and for family shall not be deducted from the zakah calculation. However, as much amount has been spent in the need before completing the year or the debt which is due whether it is in form of due school fees or the amount of food materials bought on credit or due bills they will be deducted from the zakah amount.
